In a conversation that I recently had with Jim Scarborough, our ASHRAE Government Affairs Manager in the Washington, DC office, I was informed that there is now a lobbyist involved with the promotion of the Masters or Equivalent (MOE) effort in our state. Mr. Scarborough has been actively working other organizations, such as ASME, in the "Licensing that Works" coalition that opposes the MOE for licensure.

It appears that the American Society of Civil Engineers (ASCE) has procured the services of James Feehan of Primmer (Primmer, Piper Eggleston & Cramer PC) to act as lobbyist for the MOE effort. At this time it is unknown if Mr. Feehan has been actively working on promoting MOE with local state representatives. To counter his efforts, our GGAC committee will be busy

coordinating the volunteer efforts in our State, acting as advocates, for promoting the "Licensing that Works" campaign and in opposition to the MOE. Anyone wishing to help in our efforts can contact me directly. Your help would be greatly appreciated.

The November meeting is RP night. We will have a short presentation on why RP is important and why it matters to the general ASHRAE membership.



Here Today, Here Tomorrow

What is an endowment and why is it important to ASHRAE?

Don't think of an endowment as merely an investment account. Think of an endowment as a "Gift to the Future." ASHRAE Foundation's endowment insures that its donor's gifts will support the long-term continuity and sustainability of ASHRAE and the multiple initiatives supported by the Foundation. These gifts in the form of the endowments provide a permanent source of income to support the education, research, and public service missions of ASHRAE. These endowed gifts are managed for the long-term to strike a balance between the competing demands of funding current initiatives and preserving purchasing power to fund future operations.

The source of nearly all the Foundation's endowment has come from gifts from generous ASHRAE members with an eye on the future. Many of these donors restrict their gifts to a specific purpose such as scholarships for training engineers or other restrictions that reflect the donor's priorities. Some donors provide unrestricted gifts that enable the ASHRAE Foundation to provide support for future needs that may not be obvious today.

In the past, gifts placed in endowment were limited to distributing only their net income for charitable purposes. The law governing these gifts has been updated to allow investment managers to invest for total return instead of just income. That means the spending power of your gifts are strong and the principal can grow to meet future needs. Since its founding 20 years ago, the ASHRAE Foundation has annually authorized a 5% distribution to support the purposes of the various funds.

Why do endowments matter to the average ASHRAE member?

Creating your Gift to the Future allows you to continue to give far into the future. Let's say you give an annual gift or \$1,000 to the RP campaign. If you establish an endowed fund, either now or from your estate, of \$20,000 your fund will continue to make a \$1,000 gift to support RP in perpetuity. Also, when your endowment fund grows in excess of its annual distribution, your principal increases and future distributions can grow as well

How can I make a Gift to the Future?

Endowed funds can be established now so that you can create a fund to support an ASHRAE initiative of interest to you. All it takes is a simple agreement describing your intentions. The minimum amount for an endowed scholarship is \$100,000. The minimum for an RP endowment is \$3,000. You can also create an endowment as part of your estate plans or add to an existing endowed fund from part of the generosity of your estate.

LAST MEETING MINUTES

1. Mike C. motioned to approve the meeting minutes as published. Jeremiah T. seconded. Motions carried unanimously

OFFICER REPORTS

1. Secretary - Blaine Conner

a. No items to report

2. Treasurer's Report - Peter Bailey (in absentia)

a. We were short 300 dollars last month, it may be

related to being charged for the library. The new owners of the Hampton Inn have been adjusting rates - meals increased \$2.00/plate. Rob F. working with hotel staff to maintain the status quo of the library being provided free of charge with a reservation of Champlain Room A.

- b. Nathan M. suggested if the price of the Library cannot be negotiated, meeting at VHV is a viable option. It was observed by several members of the BOG that the lobby of the Hampton may also be a good place (at no cost).
- c. Costs of dinner: It appears that ASHRAE CVC will typically break even on the cost of dinner. Rob F. stated that dinner is a fixed 21.93/plate plus a 21% tip. - e. Points:
 - i. Par for 1050, CVC has 465 to date. Tom Z. believes CVC will reach 1,400 this ASHRAE year.
- f. CVC has reached Full Circle, Josh C. is the final person remaining to get Full Circle Plus (all BOG members donating a minimum of \$100 to the ASHRAE National.
- g. RP night next month
 - i. Tom Z. to follow up with additional information.

5. Chapter Programs - Rob Ward

- a. Booked this year's distinguished lecturer for December, lecturer has eight topics to select from (to be determined at a later date). DL does not offer any PDH's,
- b. Rob W. to provide speaker information via email to BOG for review and comment.
- c. November speaker to be an Armstrong Pumps representative.

ENERGY NEWS CORNER

From the WalletHub website (www.wallethub. com) Vermont is currently listed as the most energy efficient state in the lower 48 states. From the website:

In light of National Energy Awareness Month, WalletHub measured the energy efficiency of cars and homes in each of 48 states. We did so in order to encourage consumers to improve their own energy efficiency practices.

To identify the most energy-efficient states, WalletHub analyzed 48 states based on two key dimensions, including "home-related energy efficiency" and "car-related energy efficiency." We obtained the former by calculating the ratio between the total residential energy consumption and annual degree days. For the latter, we divided the annual vehicle miles driven by the gallons of gasoline consumed. Each dimension was weighted proportionally to reflect national consumption patterns

DOE ISSUES FINAL RULE ON CERTIFICATION PROGRAMS FOR FEDERAL BUILDINGS

WASHINGTON— The U.S. Department of Energy (DOE) has issued a Final Rule to ensure that federal buildings use proper energy and water efficiency certifications. The rule, which goes into effect Nov. 13, specifies LEED Silver certification, which is required as part of the federal Energy Independence and Security Act of 2007.

However, the Green Globes program can also be used under certain circumstances. DOE says the rule "ensures that in cases where agencies choose to use green building certification systems to meet federal sustainability and energy standards, they must choose a system that verifies enhanced energy and water efficiency.

By requiring re-assessments at least every four years, the rule will ensure energy and water savings continue well beyond the initial building opening or retrofit."

HEAT PUMPS BECOMING A HOT ITEM IN COLD CLIMATES

BOSTON— Once an expensive add-on that did not work well in cold climates, heat pumps have benefited from a technological makeover, according to a Boston Globe article. The new generation of machines can keep a home warm even in extreme conditions as low as –20°F (–29°C). Although they are powered by electricity, which is usually a very expensive way to heat a home, the new heat pumps are so efficient that they cost much less to run than a conventional oil heat system. Many utility companies offer rebates to help soften the installation costs.

Sales have been climbing steadily over the past few years since manufacturers have improved components such as refrigerants, compressors, and heating coils. Modern cold-climate heat pumps can generate two to three times as much heat as an electric boiler or a baseboard heater, using the same amount of electricity.
